# **Progression in Regulation**

#### Foreign Contribution (Regulation) Act 1976

- First enactment.
- In 1985 registration mandated with remittances allowed into a designated bank account only

#### Foreign Contribution (Regulation) Act 2010

- Individuals receiving foreign contribution (FC) also regulated.
- Wide definition of organisations of a political nature with prohibition to receive FC.
- Renewal of certificate of registration every 5 years .
- Provision to cancel registration.
- On cancellation, disposal of assets created out of FC.



# **Progression in Regulation**

# 2

#### Amendment - September 2019

- Affidavit by trustees to inform the Government about any violation of Section 12(4) .

#### Amendment - September 2020

- Centralization for greater scrutiny by the Government
- All FC to land only in Delhi.
- No sub-granting
- Scrutiny on renewal
- Administration costs restricted to 20 percent



# Some Facts as of 27 October 2020

#### Active Organisations - 22,428

- 49,861 registered. 27,433 cancelled and deemed expiry. Active organisations - 22,428.

#### From 2015-2019

– About 16,000 registrations were cancelled for non-filing of returns for the period 2009-10 to 2017-18.

#### In 2016

– About 11,000 registrations were cancelled for not applying for renewal.

# **Activities Under the Lens**

#### Conversion from one religion to another

- "Person...has not been prosecuted or convicted for indulging in activities aimed at conversion through inducement or force, either directly or indirectly, from one religious faith to another;" (section 12(4) (a) (ii))
- "...has not been prosecuted or convicted for creating communal tension or disharmony in any specified district or any other part of the country;" (section 12(4) (a)(iii))
- "...the acceptance of FC is likely to affect prejudicially;
  - the public interest;
  - harmony between religious, racial, social, linguistic, regional groups, castes or communities**;**.. (section 12(4) (f))



# **Activities Under the Lens**

#### Activism

- Organisations of a Political Nature (section 3 and 5 r.w.r. 3)
- "Person is not engaged or likely to engage in propagation of sedition..." (section 12(4) (a) (v))
- The acceptance of FC is likely to affect prejudicially;
  - "the public interest";
  - "the security, strategic, scientific or economic interest of the State;" (section 12(4)(f))



# **Renewal of Registration**

#### For such a time as this

5 year cycle due October 2021

#### Risks

- Loss of permission to receive foreign contribution
- Loss of property acquired out of foreign contribution to a Government authority.

# What happened?

# An overview of constraints affecting U.S. (foreign) funding and sending ministries working in India

- New Account, No Transfers
- Limitation on administrative costs
  - shifted from 50 to 20 percent
- Luke 10.2 Pray for God to raise up workers
  - In this case, there are workers and resources available. The challenge is mobilizing them as a mountain has arisen from a government attempting to restrict gospel proclamation.



## What not to do?

# 3

#### Do not scramble

As was true for Abraham, it is not wise to take matters into our own hands.

#### Do not compromise integrity

God has this. We want to work together and avoid anything that could lead to outcomes that are not honoring to God.

#### Do not endanger others in ignorance.

The mission community is very creative at finding ways to overcome restrictions. Whether smuggling Bibles, money or workers. So, there will be a great temptation to find ways to circumvent these restrictions in our own strength.



## What to do?

#### **Unite in Prayer**

 We must unite together with humility and prayer to seek help from God to move this mountain.

#### **Encourage Peer Accountability and Creativity**

 In reliance on God and with peer accountability, we can seek creative solutions that honor God.

#### **Build up People**

- Building local capacity is not about projects, but about building faithful people for sustainable ministry.
- Perhaps God is using this to accelerate sustainability and reduce reliance on FC. Hudson Taylor said: "God's work done in God's way will never lack God's supply."

# FCRA Changes and Possible Responses

#### How can you help the ministries in India?

- First of all, we are grateful for your concern and prayers
- Your support and solidarity is much appreciated.
   Indian nonprofit space is undergoing an unprecedented challenge.
- It is necessary to re-calibrate our ways of working.

#### Stop!

- Compliance to law at both ends is non-negotiable.
- Push ministries to be compliant to local laws even if it is difficult (Not impossible)



# FCRA Changes and Possible Responses

#### What you can do!

- Follow the 5 purposes in the law and check the FIT
- Creative solutions to circumvent the law should be avoided.
- Provide some grant for capacity building in fund raising and communications for sustainability.
- Ensure that Indian partner organizations are utilizing the funds directly and not transferring to another organization.
- Proselytization is against the law in India. Screen the activities of your partners carefully.
- Watch out what goes in the social media space both in USA and in India. Remember we live in a global village.

#### Please . . .

- Let us even in passing avoid promoting non-compliance
- We should not nurture the victim mindset
- Let us not try to look for loop-holes in the law.
- Let us avoid corridor channels but rather learn from one another and from our experiences.

# Collective confession and following God's standards

- The prayer of Ezra is one of the best examples in the Bible of how to pray when we have sinned (9.5-15)
- He included himself in the Israelites failure to obey God even though he himself had not sinned.
- For Ezra had set his heart to study the Law of the LORD, and to do it and to teach his statutes and rules in Israel (7.10)
